NOTIFICATION

New Delhi, the 29th June, 2016

S.O.2234(E)- In exercise of the powers conferred by sub-section (1) of Section 3(A) of the National Highways Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government, after being satisfied that for the public purpose, the land, the brief description of which is given in the schedule below, is required for building (widening Two/Four laning , etc.), maintenance, management and operation of National Highway No.222, in the stretch of land from Km 284.000 to Km 303.100 (Kalyan-Andhra Pradesh Border Section) in District Ahmednagar in the State of Maharashtra, hereby declares its intention to acquire such land.

Any person interested in the said land may, within twenty one days from the date of publication of this notification in the Official Gazette, object to the use of such land for the aforesaid purpose under the sub-section (1) of section 3(C) of the said Act.

Every such objection shall be made to the competent authority, namely the Sub Divisional Officer, Pathardi, Shevgaon Division in writing and shall set-out the grounds thereof and the competent authority shall give the objector an opportunity of being heard, either in person or by a legal practitioner, and may, after hearing all such objection and after making such further enquiry, if any, as the competent authority thinks necessary, by orders, either allow or disallow the objection.

Any order made by the competent authority under sub-section (2) of section 3 (C) of the said Act, shall be final.

The land plans and other details of the land covered under this notification are available and can be inspected by the interested person at the aforesaid office of the competent authority.
